We are in **AYP Phase 0~Alert** for the 2010-2011 school year. We did not make Adequate Yearly Progress (AYP) because:

- ❖ We did not test 95% of our students.
  - English Language Arts: 93.8% of All Students and 94.4% of Black students were assessed.
  - Mathematics: 93.8% of All Students and 94.4% of Black students were assessed.
- ❖ We did not attain target achievement goals for all subgroups of students in mathematics.
  - Only 54.5% of All Students; 55.1% of Black and 50% of Economically Disadvantaged Students met the AYP State Objective in Mathematics.

Because our school has not made AYP for 1 year(s), it is not identified for school Improvement.

Communication and Media Arts' Plans for improving our current AYP status is as follows:

1. All ninth graders will receive additional math classes based on the pretest that all Ninth graders will take over the summer of the upcoming school year.

2. All Tenth and eleventh graders will receive Reading and Math Enrichment using a variety of resources such as weekly pull outs in Math and English courses to work on ACT/MME prep using Key train and skills tutor to increase math and English competencies.
3. All Students will test at the begin of the school year to provide teachers with much needed data to development the Math and reading skill for all students.
4. Weekend ACT/MME Prep courses free of charge for all students. The program will be facilitated by CMA staff.
5. Staff changes in the areas of Math and English.
6. Students that struggle in Reading will receive an individualized education plan that will address their reading needs. The reading improvement will be monitored by the ELA coach, Counselor, English teacher and School administration.

This year Communication and Media Arts did not Make AYP because of Math Scores, therefore, an asserted effort will be made at all grade levels to increase the overall math performance of our students with a variety of resources such as:

- Skills tutor
- quzilet.com,
- MME applied math key train program,
- Collaboration with Wayne RESA on our math program
- The use of Carnegie Math for Ninth and tenth graders to build capacity before students reach the eleventh grade.
- Parent and community workshop held at the beginning of the school year to inform all stakeholders of the importance of the MME/Act test and its impact on the school and their child's educational success.

Committing to a parent contact that will develop an academic partnership with parents that will support the schools effort to get students to read and increase their math skills.

College Readiness workshops will be held monthly. Parents are encouraged to attend parent workshops. The date will be on the school calendar which will be mailed to parents over the summer. Parents are encouraged to read with their children in our sustained reading program. Details of the program were provided to parents in the summer homework packets.

Monthly attendance at the LSCO meetings is extremely helpful. During these meetings parents are given tips on how to assist in the learning process.

## Process for assigning pupils to the school

During the 2009-2010 school year, students were required to live within the boundary of the school to which they were assigned.

During the 2010-2011 school year Open Enrollment Detroit Public Schools implemented the “Open Enrollment Initiative. This initiative allows students to elect to attend any Detroit Public School without being required to live within the boundary for that school. The “Open Enrollment Initiative” does not apply to the Examination High Schools, or Application Schools. Parents may enroll their child (ren) in the school of their interest as long as the school has not reached capacity for their particular grade. Enrollment preference is given to students who live within the boundary of a school. It should also be noted that transportation will not be provided for students who select a school outside of the boundary of their home school. ## Detroit Public Schools’ Core Curriculum:

Consistent with the District academic plan, **Excellent Schools for Every Child**, there are aggressive plans to accelerate the rate of student achievement and to ensure that students graduate with the academic and social skills necessary for success in college and the workplace.

### Specific curriculum actions include:

- \*alignment of the curriculum, lessons planning and pacing calendars to national and state standards
- \*ensuring that material and texts and supplemental resources and used in the classroom are directly linked to and with the grade expectations

- \*defined grade level expectations to create alignment throughout the school
- \* Administration and review of quarterly benchmark assessments for students in grades 3-12
- \*use pre-intervention tools such as the Dynamic Indicator of Basic Early Literacy Skills (DIBLES) to assess language fluency for students on grades Prek-2 to ensure literacy foundation for reading success
- \*use of the data (both formal and informal) to inform teaching strategies and professional development needs for staff, including but not limited to, teachers and administrators
- \*focused professional development on the use of appropriate curriculum and teaching strategies, monitoring results and developing the interventions for re-teaching, as necessary
- \*use technology (Learning Village/an on-line instructional management system) as a tool to manage instruction and teacher practice

## Access to the Core Curriculum

The instructional strategies and grade level expectations are aligned to the state standards and the NAEP. This represents the core curriculum which is supported by the texts, materials, computer software and other school level resources used daily in the classrooms. All of the professional development activities are aligned to the core curriculum.

The implementation is a process delineated in the District Plan **Excellent Schools for Every Child**. This plan serves as the framework for each school's academic achievement plan. The frequent monitoring of the implementation of these plans is conducted by the school diagnostic visits, review of the benchmark assessments, use of the teacher evaluation tool and adherence to the pacing calendar.

The variances from the state plan can be found in the grade level expectations which are also aligned to the higher standards of NAEP.

A Summer Parent University is offered with classes to increase parenting skills, early childhood literacy, adult literacy and GED. During the school year, the Regional Parent Resource Center are a vehicle for parents and other community member to participate in regular and on-going informational and participatory sessions focused on curriculum and instruction. Learning Village (an on line instructional management system)

Web updates and semi-annual progress reports are also a means to disseminate information to parents and community.

Report criteria of identifying the number and percent of students represented by parents at Parent-Teacher-Conferences.

- 1.0 Data from the PTC Forms represent “parent interactions” with teachers, per school, per card-marking.
- 2.0 Parent Interaction Definition: During Parent Teacher Conferences (and in some instances school open houses) Schools/Teachers are advised to have each parent participant provide a parent signature—a parent may not sign for a student if they did not talk about that student.
- 3.0 For a variety of reasons, five (5) DPS schools are not included in the data collection count due to some school closures and non-return of Parent Teacher Conference Signature List Documents.
- 4.0 Several DPS schools had a very high percentage of reported parent interactions. This may be due to a number of reasons. In at least three (3) instances, the calculated percentages are in excess of 100%. In each instance, each of these three (3) schools is an elementary school with a large parent turnout at each of the four (4) required conferences. If during each conference one (1) parent with two (2) students enrolled in the school visited three (3) teachers for each of their two (2) students, this would count as six (6) parent interactions, thus increasing the base number and resulting percentage.
