We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2011-2012 educational progress for the Bagley Elementary School. For 2011-2012, Bagley Elementary School did not make AYP because:

We did not meet the 90% attendance rate goal.

- Attendance Rate for All Students 86.1%; Black 86%; Students with Disabilities 85.5%; Economically Disadvantaged 86.1%.

We did not attain target achievement goals for all subgroups of students in English Language Arts.

- Only 26.7% of our Students with Disabilities met the AYP State Objective in reading.

We are actively working to address our AYP issue. Adequate Yearly Progress will be improved and enhanced as documented in our School Improvement Plan. Bagley Elementary School will integrate Response to Intervention (RTI), a data-driven three (3) tiered process that provides a structure to address individual student needs across the curriculum. The data-driven process includes, but is not limited to providing teachers with

professional development to ensure effective delivery of instruction and ongoing monitoring of student progress.

Parent Involvement

Parents are highly encouraged to be involved by reinforcing positive behavior; moreover, by reinforcing and extending the learning process in the home. Parents can be involved by:

- Making sure students are in school every day, all day and on time
- Attending parent workshops to support learning/behavior in the home
- Observe/volunteer in their child’s classroom
- Making sure students arrive to school “dressed for success” in full uniform
- Establish a Family Book Club or Family Literacy Night ...Read! Read! Read!

State law requires that we also report additional information.

Process for Assigning Pupils to the School

During the 2011-2012 school year, Detroit Public Schools implemented the “Open Enrollment Initiative.” This initiative allows students to elect to attend any Detroit Public School without being required to live within the boundary for that school. The “Open Enrollment Initiative” does not apply to the Examination High Schools, or Application Schools. Parents may enroll their child(ren) in the school of their interest as long as the school has not reached capacity for their particular grade. Enrollment preference is given to students who live within the boundary of a school. It should also be noted that transportation will not be provided for students who select a school outside of the boundary of their home school. “Open Enrollment Initiative” resources can be found on our website at:

Detroit Public Schools’ Core Curriculum:

Access to the Core Curriculum

The instructional strategies and grade level expectations are aligned to the State standards and the NAEP. This represents the core curriculum, which is supported by the texts, materials, computer software and other school level resources used daily in the classrooms. All of the professional development activities are aligned to the core curriculum.

The implementation is a process delineated in the District Plan. This plan serves as the framework for each school’s academic achievement plan.

The frequent monitoring of the implementation of these plans are conducted by the school diagnostic visits, review of the benchmark assessments, use of the teacher evaluation tool and adherence to the pacing calendar.

The variances from the State plan can be found in the grade level expectations, which are also aligned to the higher standards of NAEP.

A Summer Parent University is offered with classes to increase parenting skills, early childhood literacy, adult literacy and GED. During the school year, the Regional Parent Resource Center is a vehicle for parents and other community members to participate in regular and on-going informational and participatory sessions focused on curriculum and instruction. Learning Village (an online instructional management system), Web updates in addition, semi-annual progress reports are a means to disseminate information to parents and the community.

The Detroit Public Schools' Office of Research, Evaluation, Assessment and Accountability has developed a data collection system which has enabled the District to comply with the Annual

Education Report criteria of identifying the number and percent of students represented by parents at Parent-Teacher Conferences.

- 1.0 Data from the PTC Forms represent “parent interactions” with teachers, per school, per card-marking.
- 2.0 Parent Interaction Definition: During Parent Teacher Conferences (and in some instances school open houses) Schools/Teachers are advised to have each parent participant provide a parent signature—a parent may not sign for a student if they did not talk about that student.
- 3.0 Several DPS schools had a very high percentage of reported parent interactions. This may be due to a number of reasons. In at least seven (7) instances, the calculated percentages are in excess of 100%. In each instance, each of these seven (7) schools is an elementary school or a Foundation for Early Learners School with a large parent turnout at each of the required conferences. If during each conference, one (1) parent with two (2) students enrolled in the school visited three (3) teachers for each of their two (2) students, this would count as six (6) parent interactions, thus increasing the base number and resulting percentage.
