For 2011-2012, Edison Elementary School did not make Adequate Yearly Progress (AYP) because:

**We did not meet the 90% attendance rate goal.**

- Attendance Rate for All Students 88.2%; Black 88.2% and Economically Disadvantaged 88.2%.

We are actively working to address our AYP issues through the following:

- ❖ Continued implementation of Success-For-All (SFA) Reading Curriculum.
- ❖ Administer and review of quarterly benchmark assessments in Math for students in grades 1-12.
- ❖ Use of quarterly assessments (STAR Early Literacy, STAR Reading and SFA Roots Assessment) to place students in cooperative learning groups at their instructional level for reading.

- ❖ Continue the utilization of data to drive instruction and differentiate lessons based on students' needs via administration of assessments, data analysis and progress monitoring.
- ❖ Implementation of the School Improvement Plan with emphasis on the following strategies & activities:
  - Differentiated Instruction;
  - Cooperative Learning;
  - Accelerated Reading & Math;
- Extended Day/Year Learning;
- Job embedded Professional Development
- Support Staff.
- ❖ Continuous monitoring & evaluation of teacher effectiveness.
- ❖ Use of technology to enhance delivery of instruction to increase students' levels of interest and learning.

## Parent Involvement

Parents/Guardians can become involved in the successful education of our students as outlined in the Parent Involvement Policy/Plan and School-Parent Learning Compact. These documents provide for all levels of parent involvement, including Decision-Making through active membership on the School Improvement Team, Local School Organization and Title I Advisory Committee and participation in various school activities such as Parent-Teacher Conferences and Parent Workshops. Parents are encouraged to provide classroom assistance and chaperone field trips.

## Process for Assigning Pupils to the School

During the 2011-2012 school year, Detroit Public Schools implemented the "Open Enrollment Initiative." This initiative allows students to elect to attend any Detroit Public School without being required to live within the boundary for that school. The "Open Enrollment Initiative" does not apply to the Examination High Schools, or Application Schools. Parents may enroll their child(ren) in the school of their interest as long as the school has not reached capacity for their particular grade. Enrollment preference is given to students who live within the boundary of a school. It should also be noted that transportation will not be provided for students who select a school outside of the boundary of their home school. ### **Access to the Core Curriculum**

The instructional strategies and grade level expectations are aligned to the State standards and the NAEP. This represents the core curriculum, which is supported by the texts, materials, computer software and other school level resources used daily in the classrooms. All of the professional development activities are aligned to the core curriculum.

The implementation is a process delineated in the District Plan. This plan serves as the framework for each school's academic achievement plan.

The frequent monitoring of the implementation of these plans are conducted by the school diagnostic visits, review of the benchmark assessments, use of the teacher evaluation tool and adherence to the pacing calendar.



The variances from the State plan can be found in the grade level expectations, which are also aligned to the higher standards of NAEP.

A Summer Parent University is offered with classes to increase parenting skills, early childhood literacy, adult literacy and GED. During the school year, the Regional Parent Resource Center is a vehicle for parents and other community members to participate in regular and on-going informational and participatory sessions focused on curriculum and instruction. Learning Village (an on line instructional management system), Web updates and semi-annual progress reports are a means to disseminate information to parents and community.

Detroit Public Schools Core Curriculum is currently under revision. Pacing Charts and Curriculum guides will be posted to the Division of Teaching and Learning under the Leadership page of our website in the near future.

The Detroit Public Schools' Office of Research, Evaluation, Assessment and Accountability has developed a data collection system which has enabled the District to comply with the Annual Education Report criteria of identifying the number and percent of students represented by parents at Parent-Teacher Conferences.

- 1.0 Data from the PTC Forms represent “parent interactions” with teachers, per school, per card-marking.
- 2.0 Parent Interaction Definition: During Parent-Teacher Conferences (and in some instances school open houses) Schools/Teachers are advised to have each parent participant provide a parent signature—a parent may not sign for a student if they did not talk about that student.
- 3.0 Several DPS schools had a very high percentage of reported parent interactions. This may be due to a number of reasons. In at least seven (7) instances, the calculated percentages are in excess of 100%. In each instance, each of these seven (7) schools is an elementary school or a Foundation for Early Learners School with a large parent turnout at each of the required conferences. If during each conference, one (1) parent with two (2) students enrolled in the school visited three (3) teachers for each of their two (2) students, this would count as six (6) parent interactions, thus increasing the base number and resulting percentage.
