For 2011-2012, Gompers Elementary-Middle School did make Adequate Yearly Progress (AYP) and was named a Priority School because the school's performance is in the bottom 5% of the State based on student achievement, achievement gaps and student growth over time in the tested subjects (mathematics, reading, science, social studies and writing; as appropriate for the school grade levels tested). Information used to rank schools is based on the development of the Top to Bottom list of schools and their performance.

We are actively working to address our school's academic issues by implementing the strategies, activities and programs identified in our School Improvement Plan. We will utilize the data information collected in our Comprehensive Needs Analysis (C.N.A.) Report. Teachers will focus instruction by using best practices to improve student achievement. Teachers will collaborate among the grade- sharing strategies and results. Staff members will work as a team to gather and analyze information and make informed decisions regarding the modification of their instructional practices. All school stakeholders, including students and parents, will be engaged in creating a culture of excellence. Staff members believe that all students can learn and achieve to high standards, Students will actively be engaged in the learning process throughout the day.

Parent Involvement

Parent/Community involvement is encouraged in all aspects of student achievement and at all levels of the collaborative decision-making process via effective and continuous two-way communication between school, the home and the community. are members of our School Improvement Team. LSCO has monthly meetings, sponsor parent workshops and parent days (Fathers reading to students, grandparent's day), and are involved in all major events at our school. the majority of our parents attended Parent-Teacher Conferences.

Process for Assigning Pupils to the School

During the 2011-2012 school year Detroit Public Schools implemented the “Open Enrollment Initiative.” This initiative allows students to elect to attend any Detroit Public School without being required to live within the boundary for that school. The “Open Enrollment Initiative” does not apply to the Examination High Schools, or Application Schools. Parents may enroll their child(ren) in the school of their interest as long as the school has not reached capacity for their particular grade. Enrollment preference is given to students who live within the boundary of a school. Detroit Public Schools' Core Curriculum:

Access to the Core Curriculum

The instructional strategies and grade level expectations are aligned to the State standards and the NAEP. This represents the core curriculum, which is supported by the texts, materials, computer software and other school level resources used daily in the classrooms. All of the professional development activities are aligned to the core curriculum.

The implementation is a process delineated in the District Plan. This plan serves as the framework for each school's academic achievement plan.

The frequent monitoring of the implementation of these plans are conducted by the school diagnostic visits, review of the benchmark assessments, use of the teacher evaluation tool and adherence to the pacing calendar.

The variances from the State plan can be found in the grade level expectations, which are also aligned to the higher standards of NAEP.

A Summer Parent University is offered with classes to increase parenting skills, early childhood literacy, adult literacy and GED. During the school year, the Regional Parent Resource Center is a vehicle for parents and other community members to participate in regular and on-going informational and participatory sessions focused on curriculum and instruction. Learning Village (an online instructional management system), Web updates and semi-annual progress reports are also a means to disseminate information to parents and community.

Detroit Public Schools Core Curriculum is currently under revision. Pacing Charts and Curriculum guides will be posted to the Division of Teaching and Learning under the Leadership page of our web-site in the near future.

- 2.0 Parent Interaction Definition: During Parent-Teacher Conferences (and in some instances school open houses) Schools/Teachers are advised to have each parent participant provide a parent signature—a parent may not sign for a student if they did not talk about that student.
- 3.0 Several DPS schools had a very high percentage of reported parent interactions. This may be due to a number of reasons. In at least seven (7) instances, the calculated percentages are in excess of 100%. In each instance, each of these seven (7) schools is an elementary school or a Foundation for Early Learners School with a large parent turnout at each of the required conferences. If during each conference, one (1) parent with two (2) students enrolled in the school visited three (3) teachers for each of their two (2) students, this would count as six (6) parent interactions, thus increasing the base number and resulting percentage.
