We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2011-2012 educational progress for the Marquette Elementary-Middle School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, Adequate Yearly Progress (AYP) and teacher quality. For 2011-2012, Marquette Elementary-Middle School did not make Adequate Yearly Progress (AYP) because:

We did not meet the 90% attendance rate goal.

- Attendance Rate for All Students 81.3%; Black 81.3%; Students with Disabilities 78.7% and Economically Disadvantaged 81.3%.

We did not attain target achievement goals for all subgroups of students in mathematics.

- Only 13.1% of All of our Students; 12.5% of our Black students; 14.9% of our Students with Disabilities and 11.6% of our Economically Disadvantaged students met the AYP State Objective in mathematics.

Marquette Elementary-Middle School was also named a Priority School because the school's performance is in the bottom 5% of the State based on student achievement, achievement gaps and student growth over time in the tested subjects (mathematics, reading, science, social studies and writing; as appropriate for the school grade levels tested). Information used to rank



schools is based on the development of the Top to Bottom list of schools and their performance.

We are actively working on our AYP issue(s) by:

1. Attracting and placing highly qualified teachers in their content areas of strength
2. Using web based programs to meet individual needs of students with fidelity
3. Creating/nurturing Professional Learning Communities.

In addition to improving the school's performance, all Marquette Elementary-Middle School teachers and administrators will use recent MEAP Data and Benchmark results to identify those students that did not achieve level one and level two on the MEAP. The Instructional specialist and Title I teachers will service the students in their areas of weakness. Grade levels will develop common lesson plans and teacher made assessments to address the deficits as indicated in the assessment results. Teachers will also continue to receive intense training as it relates to programs such as Accelerated Reading and Math, Glory Math, and Destinations Learning. At least Wednesday staff meeting will include viewing a PD 360 video in an agreed upon topic

Parent Involvement

Parents are invited to be involved by:

1. Regularly attending parent teacher conferences and Title I/LSCO meetings;
2. Participate in school wide events, and encourage the use of web based academic programs such as Destination Learning and Glory Math, to increase student achievement.
3. Volunteer to work at the school site as a hall monitor, tutor.
4. Attend all school functions and events: Polar Fest, Math/Science Family Night, concerts and Awards Ceremonies, etc.

State law requires that we also report additional information.

Process for Assigning Pupils to the School

During the 2011-2012 school year, Detroit Public Schools implemented the "Open Enrollment Initiative." This initiative allows students to elect to attend any Detroit Public School without being required to live within the boundary for that school. The "Open Enrollment Initiative" does not apply to the Examination High Schools, or Application Schools. Parents may enroll

their child(ren) in the school of their interest as long as the school has not reached capacity for their particular grade. Enrollment preference is given to students who live within the boundary of a school. It should also be noted that transportation will not be provided for students who select a school outside of the boundary of their home school. Access to the Core Curriculum

The instructional strategies and grade level expectations are aligned to the State standards and the NAEP. This represents the core curriculum, which is supported by the texts,

materials, computer software and other school level resources used daily in the classrooms. All of the professional development activities are aligned to the core curriculum.

The implementation is a process delineated in the District Plan. This plan serves as the framework for each school's academic achievement plan.

The frequent monitoring of the implementation of these plans are conducted by the school diagnostic visits, review of the benchmark assessments, use of the teacher evaluation tool and adherence to the pacing calendar.

The variances from the State plan can be found in the grade level expectations, which are also aligned to the higher standards of NAEP.

A Summer Parent University is offered with classes to increase parenting skills, early childhood literacy, adult literacy and GED. During the school year, the Regional Parent Resource Center is a vehicle for parents and other community members to participate in regular and on-going informational and participatory sessions focused on curriculum and instruction. Learning Village (an online instructional management system), Web updates and semi-annual progress reports are also a means to disseminate information to parents and community.

Detroit Public Schools Core Curriculum is currently under revision. Pacing Charts and Curriculum guides will be posted to the Division of Teaching and Learning under the Leadership page of our web-site in the near future.

The Detroit Public Schools' Office of Research, Evaluation, Assessment and Accountability has developed a data collection system which has enabled the District to comply with the Annual Education Report criteria of identifying the number and percent of students represented by parents at Parent-Teacher Conferences.

- 1.0 Data from the PTC Forms represent “parent interactions” with teachers, per school, per card-marking.
- 2.0 Parent Interaction Definition: During Parent-Teacher Conferences (and in some instances school open houses) Schools/Teachers are advised to have each parent participant provide a parent signature—a parent may not sign for a student if they did not talk about that student.
- 3.0 Several DPS schools had a very high percentage of reported parent interactions. This may be due to a number of reasons. In at least seven (7) instances, the calculated percentages are in excess of 100%. In each instance, each of these seven (7) schools is an elementary school or a Foundation for Early Learners School with a large parent turnout at each of the required conferences. If during each conference, one (1) parent with two (2) students enrolled in the school visited three (3) teachers for each of their two (2) students, this would count as six (6) parent interactions, thus increasing the base number and resulting percentage.
