Golightly Career and Technical Center does not receive an Adequate Yearly Progress Status. Student assessment information can be found at each student's comprehensive high school.

Career and Technical Centers' progress falls under the State mandated classification of Core Performance Indicators. I will continue to improve students' progress by providing career pathway programs that focus on project-based learning, which integrates all core subjects and HSCEs in classroom activities. Students will receive KeyTrain Lessons; math, reading, and writing assistance associated with each program area; home-school Math/Reading/Writing assistance and ACT preparation materials. Teachers will utilize digital and online opportunities to assist in the improvement of AYP. All of our students will gain a skill in one of 16 selected program areas where hands-on and technology skills will enhance their opportunity to transfer those skills into the global workforce and/or high education.

Parent Involvement

Parents are being asked to become actively engaged by joining our volunteer corps and becoming members of the School Improvement Team, Career Speakers, Hall monitors, classroom assistants, parking lot monitors, provide technical assistance, share their talents and help to keep our campus clean. They are also given the option to help wherever it is needed. State law requires that we also report additional information.

Process for Assigning Pupils to the School

During the 2011-2012 school year Detroit Public Schools implemented the “Open Enrollment Initiative.” This initiative allows students to elect to attend any Detroit Public School without being required to live within the boundary for that school. The “Open Enrollment Initiative” does not apply to the Examination High Schools, or Application Schools. Parents may enroll their child(ren) in the school of their interest as long as the school has not reached capacity for their particular grade. Enrollment preference is given to students who live within the boundary of a school. School Description:

Students attend Golightly Career and Technical for two years during grades ten (10) and eleven (11). Sixteen program offerings provide career planning and training for jobs that match their interests and abilities with future practicum, internships. Scholarships and cooperative education experience available.

Access to the Core Curriculum

The instructional strategies and grade level expectations are aligned to the State standards and the NAEP. This represents the core curriculum, which is supported by the texts, materials, computer software and other school level resources used daily in the classrooms. All of the professional development activities are aligned to the core curriculum.

The implementation is a process delineated in the District Plan. This plan serves as the framework for each school's academic achievement plan.

The frequent monitoring of the implementation of these plans are conducted by the school diagnostic visits, review of the benchmark assessments, use of the teacher evaluation tool and adherence to the pacing calendar.

The variances from the State plan can be found in the grade level expectations, which are also aligned to the higher standards of NAEP.

A Summer Parent University is offered with classes to increase parenting skills, early childhood literacy, adult literacy and GED. During the school year, the Regional Parent Resource Center is a vehicle for parents and other community members to participate in regular and on-going informational and participatory sessions focused on curriculum and instruction. Learning Village (an online instructional management system), Web updates and semi-annual progress reports are a means to disseminate information to parents and community.

Detroit Public Schools Core Curriculum is currently under revision. Pacing Charts and Curriculum guides will be posted to the Division of Teaching and Learning under the Leadership page of our web-site in the near future.

The Detroit Public Schools' Office of Research, Evaluation, Assessment and Accountability has developed a data collection system which has enabled the District to comply with the Annual Education Report criteria of identifying the number and percent of students represented by parents at Parent-Teacher Conferences.

- 1.0 Data from the PTC Forms represent “parent interactions” with teachers, per school, per card-marking.
- 2.0 Parent Interaction Definition: During Parent-Teacher Conferences (and in some instances school open houses) Schools/Teachers are advised to have each parent participant provide a parent signature—a parent may not sign for a student if they did not talk about that student.
- 3.0 Several DPS schools had a very high percentage of reported parent interactions. This may be due to a number of reasons. In at least seven (7) instances, the calculated percentages are in



excess of 100%. In each instance, each of these seven (7) schools is an elementary school or a Foundation for Early Learners School with a large parent turnout at each of the required conferences. If during each conference, one (1) parent with two (2) students enrolled in the school visited three (3) teachers for each of their two (2) students, this would count as six (6) parent interactions, thus increasing the base number and resulting percentage.
