For 2011-2012, Edward "Duke" Ellington Elementary-Middle School did not make Adequate Yearly Progress (AYP) because:

We did not meet the 90% attendance rate goal.

- Attendance Rate for All Students 85.9%; Black 85.9%; Students with Disabilities 86.9% and Economically Disadvantaged 85.9%.

Edward "Duke" Ellington Elementary-Middle School did not make AYP (student achievement, student growth over time, school improvement over time and/or achievement gaps across each of the tested subjects (mathematics, reading, science, social studies and writing; as appropriate for the school grade levels tested. We are actively working to address our AYP issues. As stated in our School Improvement Plan, we will:

- Differentiate Instruction to reach all learners.
- Utilize reading and writing strategies across the curriculum.
- Provide After-School tutoring programs to strengthen student's skills.

- Use technology to engage learners
- Increase Instructional time with the 120 minute Literacy Block & 90 minute Math Block
- Examine and analyze data to determine where the achievement gap is occurring
- Progress Monitor to monitor improvement and adjust instruction

These reform models will increase student achievement.

Parent Involvement

Parents will be involved through SIT, LSCO meetings, Parent-Teacher Conferences, Annual Title 1 Meeting and school surveys. In addition, Duke Ellington had strong participation through the Detroit College Promise program (a scholarship opportunity for DPS students). We will engage parents, further, with this type of endeavor. These strategies will give all stakeholders the tools to assist in students' educational opportunity and success.

State law requires that we also report additional information.

Process for Assigning Pupils to the School

During the 2011-2012 school year, Detroit Public Schools implemented the "Open Enrollment Initiative." This initiative allows students to elect to attend any Detroit Public School without being required to live within the boundary for that school. The "Open Enrollment Initiative" does not apply to the Examination High Schools, or Application Schools. Parents may enroll their child(ren) in the school of their interest as long as the school has not reached capacity for their particular grade. Enrollment preference is given to students who live within the boundary of a school. It should also be noted that transportation will not be provided for students who select a school outside of the boundary of their home school. School Description:

Edward “Duke” Ellington Conservatory of Music and Art, a Pk-8 school, offers a unique, well-rounded curriculum of fine and performing arts balanced by a strong emphasis on academic achievement. Regular academic classes (Math, Science, Language Arts, Computers, Gym) as well as performing arts classes are offered. Duke Ellington Conservatory is a school of choice. Admission is by application/auditions for elementary and middle school students.

Detroit Public Schools’ Core Curriculum:

Consistent with the Detroit Public Schools Academic Plan for 2012-2013, there are aggressive plans to accelerate the rate of student achievement and to ensure that students graduate with the academic and social skills necessary for success in college and the workplace.

Specific curriculum actions are based on the District’s five (5) pillars of student achievement:

- II. High quality teaching and learning,
- III. Rigorous, transparent and continuous improvement cycle,
- IV. Customer service approach to community and each other, and
- V. A secure, inclusive and dynamic culture.

Access to the Core Curriculum

The instructional strategies and grade level expectations are aligned to the State standards and the NAEP. This represents the core curriculum, which is supported by the texts, materials, computer software and other school level resources used daily in the classrooms. All of the professional development activities are aligned to the core curriculum.

The implementation is a process delineated in the District Plan. This plan serves as the framework for each school’s academic achievement plan.

The frequent monitoring of the implementation of these plans are conducted by the school diagnostic visits, review of the benchmark assessments, use of the teacher evaluation tool and adherence to the pacing calendar.



The variances from the state plan can be found in the grade level expectations, which are also aligned to the higher standards of NAEP.

A Summer Parent University is offered with classes to increase parenting skills, early childhood literacy, adult literacy and GED. During the school year, the Regional Parent Resource Center is a vehicle for parents and other community members to participate in regular and on-going informational and participatory sessions focused on curriculum and instruction. Learning Village (an online instructional management system), Web updates and semi-annual progress reports are a means to disseminate information to parents and community.

Detroit Public Schools Core Curriculum is currently under revision. Pacing Charts and Curriculum guides will be posted to the Division of Teaching and Learning under the Leadership page of our web-site in the near future.

The Detroit Public Schools' Office of Research, Evaluation, Assessment and Accountability has developed a data collection system which has enabled the District to comply with the Annual Education Report criteria of identifying the number and percent of students represented by parents at Parent-Teacher Conferences.

- 1.0 Data from the PTC Forms represent “parent interactions” with teachers, per school, per card-marking.
- 2.0 Parent Interaction Definition: During Parent-Teacher Conferences (and in some instances school open houses) Schools/Teachers are advised to have each parent participant provide a parent signature—a parent may not sign for a student if they did not talk about that student.
- 3.0 Several DPS schools had a very high percentage of reported parent interactions. This may be due to a number of reasons. In at least seven (7) instances, the calculated percentages are in excess of 100%. In each instance, each of these seven (7) schools is an elementary school or a Foundation for Early Learners School with a large parent turnout at each of the required conferences. If during each conference, one (1) parent with two (2) students enrolled in the school visited three (3) teachers for each of their two (2) students, this would count as six (6) parent interactions, thus increasing the base number and resulting percentage.
