Annual Education Report (AER) Cover Letter (2011-2012)

We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2011-2012 educational progress for the Garvey Academy. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, Adequate Yearly Progress (AYP) and teacher quality. For 2011-2012, Garvey Academy did not make Adequate Yearly Progress (AYP) because:

We did not meet the 90% attendance rate goal.

- Attendance Rate for All Students 83.1%; Black 83.3%; Students with Disabilities 80.1% and Economically Disadvantaged 83.1%.

We did not attain target achievement goals for all subgroups of students in English language arts.

- English Language Arts: Only 92% of our Students with Disabilities were assessed.
- Mathematics: Only 92% of our Students with Disabilities were assessed.

Garvey Academy did not make AYP (student achievement, student growth over time, school improvement over time and/or achievement gaps across each of the tested subjects (mathematics, reading, science, social studies and writing; as appropriate for the school grade levels tested). We are actively working to address our AYP issues by implement the following reform strategies and initiatives in collaboration with MDE and Wayne RESA:

1. Increase Attendance Rate to 90%. Our current attendance rate is 83.3%.
2. Increase ELA and Math proficiency.

My staff and I are going to make a strong personal effort to contact parents of children with chronic attendance problems. We will stress the importance of having children come to school every day. In addition automatic computerized attendance notifications via telephone will be conducted by 10:00a.m. daily for students who have not arrived in school.

The instructional staff will continue using the district initiatives to increase achievement such as, DIBELS, Destinations, Burst Instruction, Accelerated Reader, Accelerated Math, Glory Math and the Inside Out Writing Program.

Parent Involvement

Parents are going to be involved by organizing local transportation for parents needing assistance getting their children to school due to transportation issues. The Local School Community Organizations will be leading the effort to call and encourage parents to have their children come to school during the school year.

State law requires that we also report additional information.

Process for Assigning Pupils to the School

During the 2011-2012 school year, Detroit Public Schools implemented the “Open Enrollment Initiative.” This initiative allows students to elect to attend any Detroit Public School without being required to live within the boundary for that school. The “Open Enrollment Initiative” does not apply to the Examination High Schools, or Application Schools. Parents may enroll their child(ren) in the school of their interest as long as the school has not reached capacity for their particular grade. Enrollment preference is given to students who live within the boundary of a school. School Description:

Marcus Garvey Academy is an application school, which serves students in Pre-K to 8th grade, offers a high-performing, African-centered learning environment that places an emphasis on cultural awareness, global learning and community service. The strength of the program is a focus on culture and self-awareness. Garvey Academy believes in building students' self-esteem, self-respect and pride to raise student achievement. Marcus Garvey Academy's indicators of student success include continuous improvement, commitment to community empowerment and a love of lifelong learning. The school features \$8.6 million in building upgrades and renovations of academic areas.

Detroit Public Schools' Core Curriculum:

Consistent with the Detroit Public Schools Academic Plan for 2012-2013, there are aggressive plans to accelerate the rate of student achievement and to ensure that students graduate with the academic and social skills necessary for success in college and the workplace.

Specific curriculum actions are based on the District's five (5) pillars of student achievement:

- I. Talent management,
- II. High quality teaching and learning,
- III. Rigorous, transparent and continuous improvement cycle,
- IV. Customer service approach to community and each other, and
- V. A secure, inclusive and dynamic culture.

Access to the Core Curriculum

The instructional strategies and grade level expectations are aligned to the State standards and the NAEP. This represents the core curriculum, which is supported by the texts, materials, computer soft ware and other school level resources used daily in the classrooms. All of the professional development activities are aligned to the core curriculum.

The implementation is a process delineated in the District Plan. This plan serves as the framework for each school's academic achievement plan.

The frequent monitoring of the implementation of these plans are conducted by the school diagnostic visits, review of the benchmark assessments, use of the teacher evaluation tool and adherence to the pacing calendar.

The variances from the State plan can be found in the grade level expectations, which are also aligned to the higher standards of NAEP.

A Summer Parent University is offered with classes to increase parenting skills, early childhood literacy, adult literacy and GED. During the school year, the Regional Parent Resource Center is a vehicle for parents and other community members to participate in regular and on-going informational and participatory sessions focused on curriculum and instruction. Learning Village (an online instructional management system), Web updates and semi-annual progress reports are a means to disseminate information to parents and community.

Detroit Public Schools Core Curriculum is currently under revision. Pacing Charts and Curriculum guides will be posted to the Division of Teaching and Learning under the Leadership page of our web-site in the near future.

The Detroit Public Schools' Office of Research, Evaluation, Assessment and Accountability has developed a data collection system which has enabled the District to comply with the Annual Education Report criteria of identifying the number and percent of students represented by parents at Parent-Teacher Conferences.

- 1.0 Data from the PTC Forms represent “parent interactions” with teachers, per school, per card-marking.
- 2.0 Parent Interaction Definition: During Parent-Teacher Conferences (and in some instances school open houses) Schools/Teachers are advised to have each parent participant provide a parent signature— a parent may not sign for a student if they did not talk about that student.
- 3.0 Several DPS schools had a very high percentage of reported parent interactions. This may be due to a number of reasons. In at least seven (7) instances, the calculated percentages are in excess of 100%. In each instance, each of these seven (7) schools is an elementary school or a Foundation for Early Learners School with a large parent turnout at each of the required conferences. If during each conference, one (1) parent with two (2) students enrolled in the school visited three (3) teachers for each of their two (2) students, this would count as six (6) parent interactions, thus increasing the base number and resulting percentage.
