### Annual Education Report (AER) Cover Letter (2012-2013)

We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2012-2013 educational progress for the Academy of The Americas. The AER addresses the complex reporting information required by Federal and State laws. The school's report contains information about student assessment, accountability and teacher quality. The State has identified some schools with the status of Reward, Focus or Priority. A Reward school is one that is outperforming other schools in achievement, growth, or is performing better than other schools with a similar student population. A Focus school is one that has a large achievement gap in 30% of its student achievement scores. A Priority school is one whose achievement and growth is in the lowest 5% of all schools in the State. Our school has not been given one of these labels.

The key challenges for our school are as follows:

**We did not attain Differentiated target achievement goals for all subgroups of students in reading.**

- Only 3.79% of the bottom 30% subgroup met the Differentiated target for reading.

**We did not attain Differentiated target achievement goals for all subgroups of students in writing.**

- Only 0.0% of the Bottom 30% subgroup met the Differentiated target for writing.

**We did not attain Differentiated target achievement goals for all subgroups of students in mathematics.**

- Only 0.76% of the Bottom 30% subgroup met the Differentiated target for mathematics.

**We did not attain Differentiated target achievement goals for all subgroups of students in science.**

- Only 10.42% of the All Students; 0.0% of the Bottom 30 %; 10.45% of Hispanic Students 9.40% of Economically Disadvantaged students and 9.42% of English Language Learners met the Differentiated target for science.

**We did not attain Differentiated target achievement goals for all subgroups of students in social studies.**

- Only 0.0% of the Bottom 30% subgroup met the Differentiated target for social studies.

We are actively working to address our Michigan School Scorecard issues, accelerate student achievement and close persistent gaps in achievement by implementing the following key initiatives:

- ❖ Through professional development in the areas of:

  - Sheltered Instruction Observation Protocol (SIOP)
  - Professional Learning Community Focus Teams

## Parent Involvement

Parents have many opportunities to be involved in our learning community. They are encouraged to attend:

1. Workshops and parent training specific to common core standards/grade level expectations
2. Parent training to support instruction focusing on at risk students.
3. Required attendance at the Dual Language Immersion information meetings.
4. Monthly Parent Advisory Council on Student Achievement (PACSA) meetings.
5. Logan Square Parent Mentor Program.

At Academy of The Americas, parents are welcomed and encouraged to be partners in their child's education by being a part of our LSCO/PACSA. This organization meets regularly and assists in selecting relevant parent workshops for self-improvement and assistance with academic support at home. Parents are encouraged to attend the Open House, Quarterly Parent/Teacher Conferences, and "special" school-wide activities and functions. Parents are welcome to volunteer in classrooms to assist teachers in providing quality instruction in order to meet the needs of all students. It is also highly recommended that parents use the technology portal to view daily lessons, student grades and to communicate with staff. This coming school year, parents will be trained by the Logan Square Neighborhood Association Parent Mentor Program. "The Parent Mentor Program gives the parents the opportunity to learn from the teachers and the teachers from the parents."

Additionally, parents/guardians are encouraged to become involved in the successful education of children by helping them establish S.M.A.R.T. goals, which are:

**Specific** – What, Why and How

**Measurable** – Measure progress to help stay on track and reach target dates

**Attainable** – Make a commitment to take small steps to accomplish the goals that are set

**Realistic** – Is the goal "do-able"? Not "easy" but attainable by pushing yourself

**Timely** – Set a time limit for completion and take action NOW.

## Process for Assigning Pupils to the School

During the 2011-2012 school year, Detroit Public Schools implemented the “Open Enrollment Initiative.” This initiative allows students to elect to attend any Detroit Public School without being required to live within the boundary for that school. The “Open Enrollment Initiative” does not apply to the Examination High Schools or Application Schools. Parents may enroll their child(ren) in the school of their interest as long as the school has not reached capacity for their particular grade. Enrollment preference is given to students who live within the boundary of a school.

## Access to the Core Curriculum

The instructional strategies and grade level expectations are aligned to the State standards and the NAEP. This represents the core curriculum, which is supported by the texts, materials, computer software and other school level resources used daily in the classrooms. All of the professional development activities are aligned to the core curriculum.

The implementation is a process delineated in the District Plan. This plan serves as the framework for each school’s academic achievement plan.

The frequent monitoring of the implementation of these plans are conducted by the school diagnostic visits, review of the benchmark assessments, use of the teacher evaluation tool and adherence to the pacing calendar.

The variances from the State Plan can be found in the grade level expectations, which are also aligned to the higher standards of NAEP.

Parents/Guardians are offered classes to increase parenting skills, early childhood literacy, adult literacy and GED. During the school year, the Regional Parent

Resource Center is a vehicle for parents and other community members to participate in regular and on-going informational and participatory sessions focused on curriculum and instruction. Learning Village (an online instructional management system), Web updates and semi-annual progress reports are a means to disseminate achievement information to educators. Parents will have the opportunity to monitor students’ progress, including attendance, through **Parent Connect** in the Fall.

Detroit Public Schools Core Curriculum is currently under revision. Pacing Charts and Curriculum guides will be posted to the Division of Teaching and Learning under the Leadership page of our website in the near future.

The Detroit Public Schools' Office of Research, Evaluation, Assessment and Accountability has developed a data collection system which has enabled the District to comply with the Annual Education Report criteria of identifying the number and percent of students represented by parents at Parent-Teacher Conferences.

- 1.0 Data from the PTC Forms represent “parent interactions” with teachers, per school, per card marking.
- 2.0 Parent Interaction Definition: During Parent-Teacher Conferences (and in some instances school open houses) Schools/Teachers are advised to have each parent participant provide a parent signature-a parent may not

sign for a student if they did not talk about that student.

- 3.0 Several DPS schools had a very high percentage of reported parent interactions. This may be due to a number of reasons. In at least seven (7) instances, the calculated percentages are in excess of 100%. In each instance, each of these seven (7) schools is an elementary school or a Foundation for Early Learners School with a large parent turnout at each of the required conferences. If during each conference, one (1) parent with two (2) students enrolled in the school visited three (3) teachers for each of their two (2) students, this would count as six (6) parent interactions, thus increasing the base number and resulting percentage.
