Dear Parents and Community Members:


We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2013-2014 educational progress for the Bates Academy. The AER addresses the complex reporting information required by Federal and State laws. The school's report contains information about student assessment, accountability and teacher quality. The State has identified some schools with the status of Reward, Focus or Priority. A Reward school is one that is outperforming other schools in achievement, growth, or is performing better than other schools with a similar student population. A Focus school is one that has a large achievement gap in 30% of its student achievement scores. A Priority school is one whose achievement and growth is in the lowest 5% of all schools in the State. Our school has been identified as a Reward school.

The key challenges for our school are as follows:

- **We did not test 95% of our students.**
 - Only 87.76% of the Economically Disadvantage subgroup was assessed in social studies.



The key challenges for our school are as follows: (Continued)

- **We did not attain Differentiated target achievement goals for all subgroups of students in reading.**
 - Only 61.29% of the Students with Disabilities subgroup met the Differentiated target in reading.

- **We did not attain Differentiated target achievement goals for all subgroups of students in writing.**
 - Only 70.59% of the Bottom 30% subgroup met the Differentiated target in writing.

- **We did not attain Differentiated target achievement goals for all subgroups of students in mathematics.**
 - Only 21.88% of the Bottom 30% and 45.16% of the Economically Disadvantaged subgroups met the Differentiated target in mathematics.

- **We did not attain Differentiated target achievement goals for all subgroups of students in science.**
 - Only 0.00% of the Bottom 30% subgroup met the Differentiated target in science.

- **We did not attain Differentiated target achievement goals for all subgroups of students in social studies.**
 - Only 0.00% of the Bottom 30% subgroup met the Differentiated target in social studies.

We are actively working to address our Michigan School Scorecard issues, accelerate student achievement and close persistent gaps in achievement. Bates Academy expects to maintain yearly adequate progress through the continuous implementation of our high-quality, well-rounded engaging curriculum with all students, which will be delivered with rigor, and relevance. The Bates Academy faculty will ensure that the instructional approaches include strategies, which engage students at the greatest depths of knowledge and are aligned with the goal of appropriately accelerating students' curricular exposure. All stakeholders will consciously strive for higher performance by making data driven decisions to increase academic achievement, as well as, implementing the strategies identified in our school improvement plan. Title I staff will provide small group intervention, student support, and coaching as needed. Furthermore, Title I will provide summer school, and tutoring as needed for at risk students.

Parent Involvement

The parents of Bates Academy are involved in our efforts in numerous ways. From the home, parents work diligently to ensure their children are prepared, and are in attendance, on a daily basis, as well as support their children with homework. In school, parents willingly support and uphold the school's safety guidelines, assist with our breakfast, and our lunch program, as well as participate in PASCA.

Bates parents actively hold the faculty and the administration accountable by remaining informed about the school's progress compared to established performance metrics. These metrics include, but are not limited to: (1) Increased evidence of student academic growth as defined by standardized assessment performance; (2) Student performance on District developed benchmark assessments; (3) Student academic growth as defined by the mastery of appropriate Common Core State Standards; (4) The cleanliness, safety and orderliness of the school environment, this includes the establishment of effective and efficient systems; and (5) Parent and student satisfaction as reported by satisfaction survey results.

State law requires that we also report additional information.

Process for Assigning Pupils to the School

Detroit Public Schools has an "Open Enrollment Initiative." This initiative allows students to elect to attend any Detroit Public School without being required to live within the boundary for that school. The "Open Enrollment Initiative" does not apply to the Examination High Schools or Application Schools. Parents may enroll their child(ren) in the school of their interest as long as the school has not reached capacity for their particular grade. Enrollment preference is given to students who live within the boundary of a school.

Access to the Core Curriculum

The instructional strategies and grade level expectations are aligned to the State standards and the NAEP. This represents the core curriculum, which is supported by the texts, materials, computer software and other school level resources used daily in the classrooms. All of the professional development activities are aligned to the core curriculum.

The implementation is a process delineated in the District Plan. This plan serves as the framework for each school's academic achievement plan.

The frequent monitoring of the implementation of these plans are conducted by the school diagnostic visits, review of the benchmark assessments, use of the teacher evaluation tool and adherence to the pacing calendar.

The variances from the State Plan can be found in the grade level expectations, which are also aligned to the higher standards of NAEP.

Parents/Guardians are offered classes to increase parenting skills, early childhood literacy, adult literacy and GED. During the school year, the Regional Parent Resource Center is a vehicle for parents and other community members to participate in regular and on-going informational and participatory sessions focused on curriculum and instruction. Learning Village (an online instructional management system), Web updates and semi-annual progress reports are a means to disseminate achievement information to educators. Parents will have the opportunity to monitor students' progress, including attendance, through **Parent Connect** in the Fall.

Detroit Public Schools Core Curriculum is currently under revision. Pacing Charts and Curriculum guides will be posted to the Division of Teaching and Learning under the Leadership page of our website in the near future.

The Detroit Public Schools' Office of Research, Evaluation, Assessment and Accountability has developed a data collection system which has enabled the District to comply with the Annual Education Report criteria of identifying the number and percent of students represented by parents at Parent-Teacher Conferences (PTC).

- 1.0 Data from the PTC Forms represent "parent interactions" with teachers, per school, per card marking.
- 2.0 Parent Interaction Definition: During Parent-Teacher Conferences Schools/Teachers are advised to have each parent participant provide a parent signature-a parent may not sign for a student if they did not talk about that student.
- 3.0 Several DPS schools had a very high percentage of reported parent interactions. This may be due to a number of reasons. In at least eight (8) instances, the calculated percentages are in excess of 100%. In each instance, each of these eight (8) schools may have experienced a large parent turnout at each of the

required conferences. If during each conference, one (1) parent with two (2) students enrolled in the school visited three (3) teachers for each of their two (2) students, this would count as six (6) parent interactions, thus increasing the base number and resulting percentage.
