
We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2013-2014 educational progress for the Detroit City West Side Academy of Leadership Development. The AER addresses the complex reporting information required by Federal and State laws. The school's report contains information about student assessment, accountability and teacher quality. The State has identified some schools with the status of Reward, Focus or Priority. A Reward school is one that is outperforming other schools in achievement, growth, or is performing better than other schools with a similar student population. A Focus school is one that has a large achievement gap in 30% of its student achievement scores. A Priority school is one whose achievement and growth is in the lowest 5% of all schools in the State. Our school has not been given one of these labels.

The key challenges for our school are as follows:

- **We did not meet the 80% graduation rate goal.**
  - 4-Year Cohort: 27.6%; 5-Year Cohort: 50.57%; 6-Year Cohort: 56.46%
- **We did not test 95% of our students.**
  - Only 83.78% of the All Students; 83.78% of the Black and 84.84% of the Economically Disadvantage subgroups were assessed in reading.



- Only 83.78% of the All Students; 83.78% of the Black and 84.84% of the Economically Disadvantage subgroups were assessed in writing.
- Only 81.08% of the All Students; 81.08% of the Black and 81.81% of the Economically Disadvantage subgroups were assessed in mathematics.
- Only 81.08% of the All Students; 81.08% of the Black and 81.81% of the Economically Disadvantage subgroups were assessed in science.
- Only 65.64% of the All Students; 65.41% of the Black; 65.96% of the Economically Disadvantage and 58.54% of the Student with Disabilities subgroups were assessed in social studies.
- **We did not attain Differentiated target achievement goals for all subgroups of students in writing.**
  - Only 16.0% of the All Students subgroup met the Differentiated target in writing.
- **We did not attain Differentiated target achievement goals for all subgroups of students in mathematics.**
  - Only 0.00% of the All Students subgroup met the Differentiated target in mathematics.
- **We did not attain Differentiated target achievement goals for all subgroups of students in science.**
  - Only 4.16% of the All Students subgroup met the Differentiated target in science.
- **We did not attain Differentiated target achievement goals for all subgroups of students in social studies.**
  - Only 7.14% of the All Students; 0.00% of the Bottom 30%; 7.14% of the Black and 6.41% of the Economically Disadvantaged subgroups met the Differentiated target in social studies.

We are actively working to address our Michigan School Scorecard issues, accelerate student achievement and close persistent gaps in achievement. We will strive to increase student achievement by 10% by implementing and utilizing differentiated instruction, block scheduling (increased instructional time), Professional Learning Communities, and Linked Learning which is an approach that assists with transforming the way teaching and learning occurs within the classroom.

## Parent Involvement

At West Side Academy we all agree that parent involvement at home, school and in the community directly impact each student's academic and social achievement. To this end, support will be provided for our parents by ensuring that they understand the importance of and have the skills to support their student's learning. It is understood that helping parents to be actively engaged in the educational process of our students requires the commitment and

support of our entire staff. Therefore, all staff will have an opportunity to participate in parent approved and designed job-embedded professional development that supports their ability to better support parent involvement and quality family engagement. We will use all available resources to ensure an open line of communication is available for all families. Families will be encouraged to engage and sustain dialogue to support student academic achievement. Furthermore, we will host parent workshops providing information on how to help their children at home mentally, physically, emotionally and financially. Examples of these workshops are:

- Parent Survival Kit with Reading Support
- Children Violence and Drugs with Reading Support
- Skill-building Strategies with Reading Support
- Raising A Male Child with Reading Support
- Anti-Bullying with Reading Support
- Financial Literacy with Math Support
- Power of Esteem with Reading Support


We believe that through these efforts, ultimately we will see an improvement in achievement.

### **Process for Assigning Pupils to the School**

Detroit Public Schools has an “Open Enrollment Initiative.” This initiative allows students to elect to attend any Detroit Public School without being required to live within the boundary for that school. The “Open Enrollment Initiative” does not apply to the Examination High Schools or Application Schools. Parents may enroll their child(ren) in the school of their interest as long as the school has not reached capacity for their particular grade. Enrollment preference is given to students who live within the boundary of a school.



## Access to the Core Curriculum

The instructional strategies and grade level expectations are aligned to the State standards and the NAEP. This represents the core curriculum, which is supported by the texts, materials, computer software and other school level resources used daily in the classrooms. All of the professional development activities are aligned to the core curriculum.



## Access to the Core Curriculum (Continued)

The implementation is a process delineated in the District Plan. This plan serves as the framework for each school's academic achievement plan.

The frequent monitoring of the implementation of these plans are conducted by the school diagnostic visits, review of the benchmark assessments, use of the teacher evaluation tool and adherence to the pacing calendar.

The variances from the State Plan can be found in the grade level expectations, which are also aligned to the higher standards of NAEP.

Parents/Guardians are offered classes to increase parenting skills, early childhood literacy, adult literacy and GED. During the school year, the Regional Parent Resource Center is a vehicle for parents and other community members to participate in regular and on-going informational and participatory sessions focused on curriculum and instruction. Learning Village (an online instructional management system), Web up-dates and semi-annual progress reports are a means to disseminate achievement information to educators. Parents will have the opportunity to monitor students' progress, including attendance, through **Parent Connect** in the fall.




## Parent-Teacher Conferences (Interactions):

The Detroit Public Schools' Office of Research, Evaluation, Assessment and Accountability has developed a data collection system which has enabled the District to comply with the Annual Education Report criteria of identifying the number and percent of students represented by parents at Parent-Teacher Conferences (PTC).

- 1.0 Data from the PTC Forms represent “parent interactions” with teachers, per school, per card marking.
- 2.0 Parent Interaction Definition: During Parent-Teacher Conferences Schools/Teachers are advised to have each parent participant provide a parent signature-a parent may not sign for a student if they did not talk about that student.
- 3.0 Several DPS schools had a very high percentage of reported parent interactions. This may be due to a number of reasons. In at least eight (8) instances, the calculated percentages are in excess of 100%. In each instance, each of these eight (8) schools may have experienced a large parent turnout at each of the required conferences. If during each conference, one (1) parent with two (2) students enrolled in the school visited three (3) teachers for each of their two (2) students, this would count as six (6) parent interactions, thus increasing the base number and resulting percentage.

\*Per the Evaluation Unit of the Detroit Public Schools Office of Research, Evaluation, Assessment and Accountability, data was obtained from the Advanced Placement (AP) Current Score Summary (2014) Report. This report was run July 21, 2014.
