We are in **AYP Phase 8** for the 2010-2011 school year. We did not make Adequate Yearly Progress (AYP) because:

- ❖ We did not meet the 80% graduation rate goal.
 - Graduation Rates 4-Year Cohort for All Students 74.25%; Black 81.21%; Hispanic 72.95%; White 50%; Students with Disabilities 59.52% and Economically Disadvantaged 82.25%.
 - 5-Year Cohort for All Students 78.06%; Black 89.93%; Hispanic 72.69%; White 66.67
- ❖ We did not test 95% of our students
 - English Language Arts: 58.3% All Students; 52.8% Black; 61.6% Hispanic; 62.3% Limited English Proficient; 52.4% Students With Disabilities and 58.7% Economic Disadvantaged
 - Mathematics: 53.8% All Students; 50.3% Black; 55.6% Hispanic; 56.7% Limited English
- ❖ We did not attain target achievement goals for all subgroups of students in English language arts.

- 73.1% of All Students; 68.6% of Black Students; 74.2% of Hispanic; 73.1% of Limited English Proficient; 43.3% of Students with Disabilities; and 69.5% of Economically Disadvantaged Students met the AYP State Objective in Reading.
- ❖ We did not attain target achievement goals for all subgroups of students in mathematics.
 - 60.5% of All Students; 50% of Black Students; 42.4% of Hispanic; 64.5% of Limited English Proficient and 59.9% of Economically Disadvantaged Students of Economically Disadvantaged Students met the AYP State Objective in Mathematics.

Because our school has not made AYP for 9 year(s), we are identified for Restructuring School Audit and Mandatory Changes.

In order to improve our AYP status we will implement the objectives and strategies in our School Improvement Plan.
