### Annual Education Report (AER) Cover Letter (2012-2013)

Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2012-2013 educational progress for the Noble Elementary-Middle School. The AER addresses the complex reporting information required by Federal and State laws. The school's report contains information about student assessment, accountability and teacher quality. The State has identified some schools with the status of Reward, Focus or Priority. A Reward school is one that is outperforming other schools in achievement, growth, or is performing better than other schools with a similar student population. A Focus school is one that has a large achievement gap in 30% of its student achievement scores. A Priority school is one whose achievement and growth is in the lowest 5% of all schools in the State. Our school .

The key challenges for our school are as follows:

**We did not attain Differentiated target achievement goals for all subgroups of students in reading.**

- Only 1.82% of the Bottom 30% subgroup met the Differentiated target for reading.

**We did not attain Differentiated target achievement goals for all subgroups of students in writing.**

- Only 0.0% of the Bottom 30% subgroup met the Differentiated target for writing.

**We did not attain Differentiated target achievement goals for all subgroups of students in mathematics.**

- Only 0.0% of the Bottom 30% subgroup met the Differentiated target for mathematics.

**We did not attain Differentiated target achievement goals for all subgroups of students in science.**

- Only 0.0% of the Bottom 30% and 8.93% of the Economically Disadvantaged subgroups met the Differentiated target for science.

**We did not attain Differentiated target achievement goals for all subgroups of students in social studies.**

- Only 7.02% of the All Students, 0.0% of the Bottom 30%; 7.27% of the African American and 7.69% of the Economically Disadvantaged subgroups met the Differentiated target for social studies.

We are actively working to address our Michigan School Scorecard issues, accelerate student achievement and close persistent gaps in achievement by implementing the following key initiatives:

- We will incorporate in every classroom-differentiated instruction and provide training to teachers who are in need of assistance.
- We will include the extended year school to every Noble student.
- We will provide a full time school social worker who will provide support groups for students who are in need of social/behavioral interventions.
- We will provide small group instructions, such as the “Burst Intervention” in early literacy skills.
- The students will have the opportunity to participate in the school after school program, in the areas of reading and math instruction.
- The school counselor will provide small group and whole class intervention strategies that will promote positive academic change.

**Parent Involvement**

We will have the parents involved in two (2) family night activities such as:

1. Math and Science Gizmos
  2. Family Literacy Games Night
- Summer Professional Development that will include all four (4) academic subject areas and also technology application. This will be a two (2) day professional development in July of 2013. We will roll out the academic plan for the 2013/14 school year and give them information on reading and math common core curriculum.
  - They will also be provided monthly neighborhood legal service professional development on student's achievement and attendance.
  - As part of the DHS Pathway to Potential Program, we have a DHS worker who provides community support to the parents and students as needed.
  - We provide a Community in Schools Coordinator who provides and assist students with social and emotional support as needed.
  - Johns Hopkins provides assistance in using data to improve instruction and students outcomes. They also will assist the parents in understanding how to work with their children to improving academic achievement.
  - City Year Core-Members provide academic support by way of small group instruction.
  - We will provide Resource Coordinating Team support to parents and students, giving recommendations for classroom interventions and remediation's.

State law requires that we also report additional information.

### **Process for Assigning Pupils to the School**

During the 2011-2012 school year, Detroit Public Schools implemented the "Open Enrollment Initiative." This initiative allows students to elect to attend any Detroit Public School without being required to live within the boundary for that school. The "Open Enrollment Initiative" does not apply to the Examination High Schools or Application Schools. Parents may enroll their child(ren) in the school of their interest as long as the school has not reached capacity for their particular grade. Enrollment preference is given to students who live within the boundary of a school.

It should also be noted that transportation will not be provided for students who select a school outside of the boundary of their home school. ## Access to the Core Curriculum

The instructional strategies and grade level expectations are aligned to the State standards and the NAEP. This represents the core curriculum, which is supported by the texts, materials, computer software and other school level resources used daily in the classrooms. All of the professional development activities are aligned to the core curriculum.

The implementation is a process delineated in the District Plan. This plan serves as the framework for each school's academic achievement plan.

## Access to the Core Curriculum (Continued)

The frequent monitoring of the implementation of these plans are conducted by the school diagnostic visits, review of the benchmark assessments, use of the teacher evaluation tool and adherence to the pacing calendar.

The variances from the State Plan can be found in the grade level expectations, which are also aligned to the higher standards of NAEP.

Parents/Guardians are offered classes to increase parenting skills, early childhood literacy, adult literacy and GED. During the school year, the Regional Parent Resource Center is a vehicle for parents and other community members to participate in regular and on-going informational and participatory sessions focused on curriculum and instruction. Learning Village (an online instructional management system), Web updates and semi-annual progress reports are a means to disseminate achievement information to educators. Parents will have the opportunity to monitor students' progress, including attendance, through **Parent Connect** in the Fall.

Detroit Public Schools Core Curriculum is currently under revision. Pacing Charts and Curriculum guides will be posted to the Division of Teaching and Learning under the Leadership page of our website in the near future.

The Detroit Public Schools' Office of Research, Evaluation, Assessment and Accountability has developed a data collection system which has enabled the District to comply with the Annual Education Report criteria of identifying the number and percent of students represented by parents at Parent-Teacher Conferences.

- 1.0 Data from the PTC Forms represent “parent interactions” with teachers, per school, per card marking.
- 2.0 Parent Interaction Definition: During Parent-Teacher Conferences (and in some instances school open houses) Schools/Teachers are advised to have each parent participant provide a parent signature—a parent may not sign for a student if they did not talk about that student.
- 3.0 Several DPS schools had a very high percentage of reported parent interactions. This may be due to a number of reasons. In at least seven (7) instances, the calculated percentages are in excess of 100%. In each instance, each of these seven (7) schools is an elementary school or a Foundation for Early Learners School with a large parent turnout at each of the required conferences. If during each conference, one (1) parent with two (2) students enrolled in the school visited three (3) teachers for each of their two (2) students, this would count as six (6) parent interactions, thus increasing the base number and resulting percentage.
