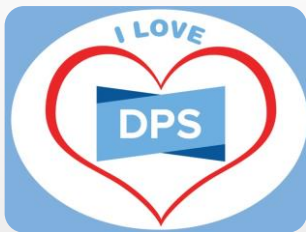

### 2014-2015 School Annual Education Report (AER) Cover Letter

We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2014-2015 educational progress for the Clippert Academy. The AER addresses the complex reporting information required by Federal and State laws. The school's report contains information about student assessment, accountability and teacher quality. Due to the Michigan Department of Education's transition to the Michigan Student Test of Educational Progress (M-STEP), Accountability data for the 2014-2015 school year does not include school/district-level proficiency targets or final accountability outcomes. This information will resume being a part of the Annual Education Report starting with 2015-2016 data. Graduation, Attendance and Participation Rates are included as a part of the Annual Education Report for the 2014-2015 school year. Our school does not have challenges in these areas.

We are actively working to accelerate student achievement and close persistent gaps in achievement. Our School Improvement Plan details strategies to improve student achievement. These strategies are comprised of increasing and maintaining bilingual and highly qualified staff, resource staff, regular access to the library/media center, technology –computer lab, green house, urban garden, integrating arts in the curriculum, reading and writing across the curriculum, cross curriculum lessons, utilizing student planners to promote organization and accountability to complete assignments, hands-on activities, differentiated instruction, multi-tier system of support for identified students, field trips, M-STEP and Smarter Balanced practice tests, after-school and summer enrichment programs, extended learning activities, use of supplemental materials and technology in the classrooms, creating Professional Learning Communities, and professional development for all stakeholders.

## **Parent Involvement**

In order to increase parental involvement, Clippert Academy Middle School has created a parent corner where parents have access to computers, printers, internet, a copy/fax machine and telephone. Clippert also provides meals for parents at PTA meetings and established a resource bank for parents with specific needs such as food, clothing, alternate housing, school Guidance Counselor, school Social Worker, resource support staff, and support for students' whose parents are migrant workers, participation in the Gleaners Program and food baskets to address the economically disadvantaged. Parents are encouraged to participate in school activities such as the Ethnic Luncheon, Fun Fair, field trips, and Career Day. Clippert welcomes parents to volunteer time in the lunchroom and during testing. Parents may request that their child be placed on daily or weekly progress reports to keep parents informed of their progress.

Clippert Academy Middle School hosts a Family Math and Science night to help parents connect with current trends in academics. Family Math and Science enables parents to experience what their child experiences in a controlled environment fostering an understanding of the level of academic demands placed on the student. The Art, Science, Math, English and Counseling departments plan activities such as the National Junior Honor Society Induction Ceremony, Science Fair, Spelling Bee, Detroit Balloon Contest, Detroit College Promise Scholarship program, Academic Games, and Math-A-Thon which require parental support and involvement. Parents also have the opportunity to volunteer at Clippert's soccer practices, as well as to attend Clippert soccer games, the soccer team dinner, and the soccer family picnic at the end of the year.

State law requires that we also report additional information.

## **Process for Assigning Pupils to the School**

### **Open Enrollment Initiative**

Detroit Public Schools has an “Open Enrollment Initiative.” This initiative allows students to elect to attend any Detroit Public School without being required to live within the boundary for that school. The “Open Enrollment Initiative” does not apply to the Examination High Schools or Application Schools. Parents may enroll their child(ren) in the school of their interest as long as the school has not reached capacity for their particular grade. Enrollment preference is given to students who live within the boundary of a school. It should also be noted that transportation will not be provided for students who select a school outside of the boundary of their home school. “Open Enrollment Initiative” resources can be found on our website at:

### **Application Schools**

Detroit Public Schools has twenty-two (22) schools that require an application for enrollment. Families can apply during the application process window. Applications are open to families of current Detroit Public Schools students as well as those newly enrolling or attending school elsewhere. The District uses one application for its Application Schools. Please note requirements on the application for submission of report cards, test data, transcripts, essay and Grade Point Average information. Schools also may have other individual entry requirements. Be prepared to provide behavior reports.

### **Examination High Schools**

During the Examination High Schools application window, all 8th grade students attending public and non-public schools are eligible to apply for admission to the 9th grade at Cass Technical High School, Renaissance High School and Martin Luther King, Jr. Senior High School’s Mathematics, Science and Applied Technology (MSAT) and Center for International Studies and Commerce programs. Residency is not required. During the beginning of the school year, students must complete and submit an application to take the placement examination.

## Examination High Schools (Continued)

Students must submit an application to be eligible to take the examination. Completed applications and all required documents must be submitted to the student's current school or the Detroit Public Schools' Office of Research and Assessment. Detroit Public Schools' students who submit an application will test at their middle school. Non-Detroit Public Schools' students who submit an application will be notified of their testing date and location by mail. Applications may be mailed.

This plan serves as the framework for each school’s academic achievement plan. The frequent monitoring of the implementation of these plans are conducted by the school diagnostic visits, review of the benchmark assessments, use of the teacher evaluation tool and adherence to the pacing calendar. Parents/Guardians are offered classes through Parent University to increase parenting skills, early childhood literacy, adult literacy and GED. During the school year, the Parent Resource Centers are a valuable resource that allow parents and other community members to participate in regular and on-going informational and participatory sessions focused on curriculum and instruction. The Detroit Public Schools Hub, Web up-dates and semi-annual progress reports are a means to disseminate achievement information to educators.

## Parent-Teacher Conferences (Interactions)

The Detroit Public Schools' Office of Research and Assessment has developed a data collection system which has enabled the District to comply with the Annual Education Report criteria of identifying the number and percent of students represented by parents at Parent-Teacher Conferences (PTC).

- 1.0 Data from the PTC Forms represent "parent interactions" with teachers, per school, per card marking.
- 2.0 Parent Interaction Definition: During Parent-Teacher Conferences (and in some instances school open houses) Schools/Teachers are advised to have each parent participant provide a parent signature-a parent may not sign for a student if they did not talk about that student.
- 3.0 Some Detroit Public Schools had a very high percentage of reported parent interactions. This may be due to a number of reasons. In at least two (2) instances, the calculated percentages are in excess of 100%. In each instance, each of these two (2) schools may have experienced a large parent turnout at each of the required conferences. If during each conference, one (1) parent with two (2) students enrolled in the school visited three (3) teachers for each of their two (2) students, this would count as six (6) parent interactions, thus increasing the base number and resulting percentage.

Our staff wishes to encourage our students, parents, community and stakeholders to continue to have faith in our commitment to meet the educational needs of our students. Our resolve is firm; we will meet the challenge of “creating a successful future” for our students.
